



## Invitation of Expression of Interest (For Pre-qualification of Consulting Firms/Companies/Institutions to Provide Testing Services)



According to the Chief Minister's vision of growth and development in the Province, the Government departments need capacity building and facilitation to make the implementation process of development projects efficient, smooth, successful and cost effective to maximize the service delivery on faster pace. To have a short term measure of building capacity of Govt. departments, a smart and cost effective solution is approved by the Chief Minister enabling P&D Department to pre-qualify/shortlist competent and qualified Firms/Companies/Institutions.

Government of the Punjab requires Firms/Companies/Institutions having expertise in the **testing services**, who may be engaged for the purpose of selecting candidates to fill the vacant posts (as and when required). The firms will be prequalified/shortlisted for a period of one year, which may be engaged by different line departments & executing agencies in Provincial and District Government on time to time basis to tackle their urgent and recurrent needs as per revised PPRA Rules 2014. Respective Government Departments and Agencies may issue Request for Proposal (RFP) to the pre-qualified / shortlisted Firms and Companies as and when required following the Clause No. 16 of PPRA Rules, 2014.

Interested Firms/Companies/Institutions, meeting the below mentioned criteria as a prerequisite for pre-qualification/shortlisting may collect the Pre-Qualification Document (PQD), available from **August 03, 2016** between the office timings i.e., 08:00 am – 04:00 pm from the Office of **Directorate General, M&E, P&D Department, Room No. 515, P&D Department** by submitting a Pay Order / Demand Draft of Rs. 500/- (non-refundable) drawn on the name of **Director General (M&E), P&D Department**. **Last date for submission of EOIs containing all the information as per PQD is August 18, 2016 till closing of the office hours**, which should be received by post.

### **PREREQUISITE FOR PRE-QUALIFICATION / SHORTLISTING**

- Registration with the relevant professional body (if any)
- Registration with the SECP, Registrar of Firms etc.
- NTN Registration
- Minimum Rs.5.0 million annual turnover by the Firm/Company/Institution
- Firm/Company/Institution has neither been Blacklisted by any Federal, Provincial, District Government Department and / or by any Government owned Company/ Foundation / Authority) nor is under any Litigation

Pre-qualification will purely be done on merit according to the criteria defined in PQD. However, pre-qualification / shortlisting of any Firm/Company/Institution does not guarantee award of work and it depends on technical and financial evaluation of proposal submitted by Consultants for a specific work at a later stage in accordance with amended Clause 16 of PPRA Rules, 2014.
