The bid shall be opened on the same date at 10:30 A.M. in the presence of the bidders or their authorized representatives who chose to be present.

All Financial Bids must be accompanied by Bid Security i.e, 2.5% of estimated price in shape of CDR in favor of Director General (M&E), P&D Board in terms of Rule 27 of Punjab Procurement Rules (PPRA), 2014. A copy of the bid security/instrument (CDR) will also be submitted with the Technical Bid, failing which it will be presumed that No bid security, (Original) has been provided along with Financial Bid.
